

FORM CFW 1: APPLY TO HAVE A COURT FEE WAIVED

Guidance Note: The court service cannot waive the court fee for applications in these proceedings:

- Proceedings in connection with the administration or winding up of a deceased person's estate
- Proceedings to enforce a mortgage or other charge over property
- Proceedings for the possession of premises
- Proceedings for defamation
- Proceedings for breach of copyright, patent or trademark
- Proceedings under admiralty law
- Proceedings to wind up or dissolve a company or to restore a company to the Register of Companies
- Proceedings under the Electoral Ordinance 1988
- Proceedings under the Licensing Ordinance 1994 other than section 76 (prohibition orders).
